
Our Story

1930's

Ken Giles lives in the Phinney Ridge neighborhood with his parents and two brothers on 88th & Fremont.


Kash serves Ken's mother, Genevieve, at the butcher counter


Ken's sons Greg, Steve & Scott form a company and purchase the Queen Anne store.
